

Swimming Pool Waiver and Release of Liability Form Release of Liability, Waiver of Claims, Assumption of Risk, and Indemnity Agreement

PLEASE READ CAREFULLY, BY ELECTRONICALLY SIGNING THIS DOCUMENT, YOU CHOOSE TO WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

Re: William and Angela Bouknight (the OWNERS)

I wish to swim at William and Angela Bouknight's pool facilities. By swimming in the William and Angela Bouknight's pool, I recognize and consent to the following:

- At no time is there a lifeguard on duty., Swimmers are responsible for the safe use of pool facilities.
- Swimmer's use of the pool facilities may involve certain risks including but not limited to:
 1. The risk of injuries resulting from possible malfunction of pool equipment.
 2. The risk of injuries resulting from tripping or falling over obstacles in the pool area.
 3. The risk of injuries resulting from collisions among/between unsupervised swimmers.
 4. The risk of other injuries resulting from participating in any action in the pool.
- I recognize and fully understand that the above list is not a complete or exhaustive list of all possible risks. In exchange for THE OWNERS allowing me to utilize the pool and pool area I hereby agree to the conditions below. I fully intend and choose to give up the legal rights as stated below:
 1. TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against THE OWNERS, its directors, officers, employees, agents, or representatives (hereinafter referred to as the "THE OWNERS") relating to my use of the pool and pool area.
 2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury, expense, or other cost that I may suffer or that my next of kin may suffer in connection with my use of the pool or pool area to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE OWNERS.
 3. TO HOLD HARMLESS AND INDEMNIFY THE OWNERS from any and all liability to property, or personal injury to, any third party, resulting from the use of the pool or pool area.
 4. That I am over the age of 18 or, under the age of 18, a parent/guardian responsible for the swimmer and in good standings with fees, has signed this form after communicating to the swimmer the rules of the property thereby taking responsibility for the swimmer while on site.
 5. That this Waiver, Release, and Agreement is fully effective and shall be effective and binding upon me, and my heirs, next of kin, executors, administrators, and assigns, or anyone else authorized to act on my behalf or on behalf of my estate.

I have read and understood this document. I am aware that by signing this document, I am waiving certain legal rights that I may have against the Releasees, and I fully agree to do so. I also acknowledge that should I (the swimmer) be doing anything considered inappropriate or disorderly, or disrupting to other swimmers, I may be asked to leave by THE OWNERS. Should multiple complaints be made it will be required that I (the swimmer) only be at the pool or pool area with my parent/guardian.
